Balance Sheet

Income Statement:

Revenue is unfavorable to budget by \$58.61 due to a foreclosure bad debt write off. We do have some savings in Late fee of \$285.00

Administrative Expenses are unfavorable to budget by \$553.41 due to Legal expense (\$455.25) and Administrative Expense (\$100.28).

Grounds Maintenance expenses are favorable to budget by \$1,210.56 due to savings in Plants, Trees and Shrubs (\$325.00), Flower Maintenance (\$276.66), Landscape Contract (\$202.00), Grounds/Common Area (\$175.00), and Snow Removal (\$155.00).

Utilities expenses are favorable to budget by \$264.37 due to savings in Water (\$134.35) and Gas and Electricity (\$130.02).

Net Operating Income of \$8,730.90 is favorable to budget by \$862.91 due to the items mentioned above.

Reserve Fund:

The reserve fund Net Income of \$3,099.66 is unfavorable to budget by \$65.74 due to the unbudgeted Electric Repairs of \$834.04 and lower interest income. We do have savings in Reserve Tree Replacement of \$1,000.00 due to no expense so far this year.
